

### 1. Definitions

For ease of reference:

- **“Yatra” / “Trip”** means the Kailash Mansarovar pilgrimage package, including related tours/treks/expeditions, logistics and services.
- **“Participant” / “I/me/my”** means the undersigned applicant.
- **“Authorities”** means all governmental, quasi-governmental, defence, border, immigration, health and land management authorities of India, Nepal and the People’s Republic of China (including TAR authorities).
- **“Force Majeure Event”** includes, without limitation: extreme weather, landslides, floods, earthquakes, epidemics/pandemics, closure of borders/routes, changes in India–China relations, visa/permit delays or denials, government orders/advisories, strikes, riots, civil commotion, curfews, acts of war/terrorism, airline/transport disruptions, and any event beyond TTT’s reasonable control.
- **“Permit”** includes any entry/exit pass, visa, route/area permission or police/defence clearance needed for the Yatra.

*Reason:* These definitions avoid ambiguity and reflect the unique cross-border, high-altitude context of the Yatra.

### 2. Personal Declaration & Assumption of Risk

**2.1 Confirmation.** I hereby apply to participate in the Yatra organised and facilitated by TTT and agree to be bound by this Registration-cum-Declaration and the Terms herein.

**2.2 High-Altitude & Remote Area Risks.** I understand the Yatra is conducted at high altitude with limited infrastructure, variable weather, possible road closures and medical constraints. Risks include, inter alia, **Acute Mountain Sickness (AMS), HAPE, HACE**, hypothermia, dehydration, falls, rockfall, animal hazards, and limited evacuation/oxygen availability.

**2.3 Assumption of Risk & Covenant Not to Sue.** To the **maximum extent permitted by applicable law**, I voluntarily assume all inherent and incidental risks and **agree not to sue** TTT in respect of such risks.

**2.4 Release.** I hereby **release and discharge** TTT, its directors, officers, employees, agents, licensees, guides, representatives and the concerned land/route Authorities (collectively, **“TTT & Personnel”**) from any cost, liability, loss or damage arising out of injury, illness, death or property loss sustained by me during the Yatra.

**2.5 Indemnity.** I agree to **indemnify and hold harmless** TTT & Personnel from all claims, costs and expenses (including medical evacuation, rescue, hospitalisation, quarantine, legal costs) arising from: (a) my breach of this document or of laws/Permit conditions; (b) my acts/omissions; or (c) my pre-existing non-disclosed medical conditions.

*Reason:* Kailash Yatra has certain inherent risks & uncertainties; this clarifies what TTT & Personnel can and cannot be liable for.

### 3. Medical Fitness & Disclosures

**3.1 Mandatory Fitness.** I declare I am physically and mentally fit for high-altitude travel and have obtained a fitness clearance from a **registered medical practitioner (MBBS or higher)** specifically addressing high-altitude trekking.

**3.2 Full Disclosure.** I have disclosed all relevant medical history, medications and allergies. I shall carry my prescribed medications and declare them if required by the Authorities.

**3.3 Right to Refuse/Withdraw.** TTT may, at its discretion and/or upon medical advice, refuse participation or require withdrawal if my health or conduct poses risk to me/others; **any refund**, if applicable, shall be processed as per Section 8 of this form.

**3.4 Emergency Care.** I consent to first aid and medical treatment as deemed necessary. Evacuation (including air/road/animal portage), extra transportation, supplementary oxygen and medical costs or any cost related to this shall be **to my account**.

*Reason:* Evacuation and advanced care can be delayed or unavailable in remote, high-altitude areas.

#### **4. Passport, Visa & Permits**

**4.1 Validity.** My passport will be valid for at least **7 months** from departure (Kathmandu/Lucknow/Nepalgunj) and shall have **minimum three blank pages**.

**4.2 Authority Discretion.** Issuance/denial/revocation of visas/Permits is **solely at the discretion** of the respective Authorities. TTT is not liable for decisions or delays of Authorities.

**4.3 Compliance.** I shall obey all laws, Permit conditions, route restrictions, photography bans, baggage checks and instructions of the Authorities/escort personnel. Breach may lead to immediate exclusion without refund.

*Reason:* The route depends on sovereign permits; compliance is mandatory.

#### **5. Itinerary, Service Level & Changes**

**5.1 Indicative Itinerary.** The published itinerary is **indicative**. Weather, roadblocks, health issues, Authority orders or other operational reasons may require changes, substitutions or cancellations of segments, night halts, vehicles, aircraft, guides or hotels/guesthouses (which may be **basic** given location).

**5.2 No Guarantee of Weather, Darshan/Parikrama.** Completion of Parikrama/Darshan is **not guaranteed**; safety and Authority directions prevail. Decision regarding Mount Kailash Parikrama for the group or individuals would be taken by Tibetan guide on the basis of weather & health of individuals & that would be final.

**5.3 Delays.** Start/arrival times Yatra durations are subject to change; late running or missed connections caused by third parties/Force Majeure shall not be deemed TTT default.

**5.4 Additional Costs.** Any extra costs due to route changes, additional nights, evacuations, medical care, food, pony/porters or transport caused by Force Majeure or personal reasons shall be **payable by the Participant** on actuals.

*Reason:* Remote terrain and permit regimes make flexibility essential.

#### **6. Prices, Currency & Payment**

**6.1 Booking & Non-Refundable Advance.** Registration is confirmed upon receipt of **INR 15,000 (Indian nationals) / USD 300 (non-Indian nationals)** as **non-refundable** advance.

**6.2 Balance & Due Dates.**

(a) **Balance is payable no later than 45 days** prior to departure; non-payment triggers **automatic cancellation** as per Clause 9.

(b) In all cases, **full payment must reflect at least 45 days** prior to departure; without full payment, **commencement is not permitted**.

**6.3 Currency & FX.** Package Transactions to Chinese Authorities in Tibet are in **USD**. INR pricing references **1 USD = INR 88**. If the applicable exchange rate **increases** on the date of final payment/settlement, the **difference is payable by the Participant**.

**6.4 Price Variations.** Prior to departure, prices may be revised for reasons including changes in exchange rates, fuel/airfares, airport/ground operator tariffs, taxes, or Authority-mandated costs. Any upward revision must be paid before departure.

*Reason:* The trip is USD-indexed and sensitive to third-party tariffs and FX movement.

#### **7. Amendments by Participant**

**7.1 Before 45 Days.** One amendment (date/name correction/upgrade) **without charge** if requested in writing before **45 days** from departure and **before** Permit application.

**7.2 Within 45 Days or Pre-Permit.** Amendments attract an administration fee of **INR 7500 (Indian passport holders) / USD 100 (non-Indian passport holders)** per change; **no alterations** are allowed **after Permit is applied**.

## 8. Cancellation by Participant & Refunds

**8.1 Form & Date.** Cancellations must be **in writing**; the effective date is when received by TTT during business hours.

**8.2 Policy.**

- **Registration advance: Non-refundable.**
- **≥ 45 days before departure:** Refund of amounts paid less registration advance and irrecoverable third-party/Permit/Visa/bank charges.
- **30–45 days before departure: 75% refund of amounts paid excluding registration advance** (or equivalently, **25% forfeiture** plus non-recoverable registration amount).
- **< 30 days before departure, or no-show/: 100% forfeiture.**

**8.3 Unutilised Services.** No refund for unutilised services, missed segments or voluntary withdrawals. No

*Reason:* Permits, tickets and remote logistics are often non-recoverable once actioned.

## 9. Cancellation/Postponement by TTT; Force Majeure

**9.1 Right to Cancel/Modify.** TTT may change, postpone or cancel the Yatra, in whole or part, due to a Force Majeure Event or Authority direction, where safety so requires or in case of non-completion of initial documentation in 30 days of booking amount payment. In this scenario also cancellation policy as per section 8 will be applicable.

**9.2 Carrying Forward.** If the Yatra cannot operate in **2026** due to Authority non-permission or Force Majeure, the booking may be **shifted to the next available season/year**; any **increase** due to USD movement or Authority/operator tariffs shall be **payable by the Participant**.

**9.3 No Damages.** In Force Majeure/Authority-driven changes, the Participant shall not claim compensation, consequential or special damages, loss of earnings, or pain/suffering. Refunds, if any, shall be limited to recoveries from third parties and/or as expressly provided herein. TTT will not be liable to compensate anything for your tickets to the Yatra starting point, any losses incurred due to date change or postponement of Yatra or anything beyond the service scope of TTT.

*Reason:* Decisions of Tibet Autonomous Region/Chinese/Nepal/Indian Authorities and weather can change at short notice.

## 10. Conduct, Compliance & Exclusion

**10.1 Lawful Conduct.** I shall comply with laws, Permit conditions and instructions of TTT guides/escort & local authorities in Yatra. Possession of **unlawful drugs, firearms, political propaganda or restricted items** will lead to **immediate exclusion** without refund and may attract prosecution by Authorities.

**10.2 Group Safety.** I shall not leave the group/route without permission and shall promptly report altitude or health symptoms.

**10.3 Baggage/Valuables.** Baggage is carried at **owner's risk**. TTT is not a common carrier and is not liable for loss/theft/damage of baggage/valuables.

## 11. Airlines & Third-Party Suppliers

**11.1 Independent Operators.** Airlines, transporters, hotels/guesthouses and ground operators are **independent contractors**. Their schedule changes, delays or cancellations do not constitute TTT's cancellation.

**11.2 Limits.** Carriage is subject to each carrier's conditions and liability limits.

## 12. Insurance (Optional, Not part of package)

**12.1 Participant's Responsibility.** Trip price **does not include insurance**. I shall procure adequate travel insurance covering at least: personal accident, medical expenses, evacuation/repatriation, trip cancellation/curtailment, loss of baggage and personal effects, and high-altitude trekking.

### 13. Data, Images & Communications

13.1 **KYC/Permit Data.** I consent to TTT using and sharing my passport/ID/medical/contact data with Authorities/partners strictly for Yatra formalities.

13.2 **Photography/Media.** I consent to reasonable group photography for tour records/TTT's non-defamatory promotional use, subject to Authority restrictions.

13.3 **Notices.** TTT has right to use my Yatra photograph & videos to use on its website & other platform for informational or promotional purposes.

### 14. Limitations, Governing Law & Dispute Resolution

14.1 **Limitation of Liability.** To the **maximum extent permitted by law**, TTT's aggregate liability, if any, shall **not exceed** the amounts actually paid by me to TTT for the Yatra; no liability for indirect, incidental, special or consequential loss is accepted.

14.2 **Notification Period.** Any claim must be notified to TTT **within 5 days** of trip end; failing which it shall be deemed waived.

14.3 **Governing Law & Jurisdiction.** This document is governed by the laws of India. **Courts at Prayagraj (Allahabad), Uttar Pradesh (High Court of Judicature at Allahabad)** shall have **exclusive jurisdiction**.

14.4 **Severability & Entire Agreement.** If any provision is held invalid, the remainder shall continue in force. This document, together with the detailed itinerary and written communications from TTT, constitutes the **entire agreement** and supersedes prior representations. No oral modification is valid; amendments must be in **writing** signed by an authorised TTT signatory.

### 15. Acknowledgement

I have carefully read and understood this Registration-cum-Declaration & Terms (including the reasons stated). I accept the risks and **agree to abide** by all terms, conditions and instructions.

Simikot & Hilsa are stays used as back up stays depending on the flights and helicopter schedule (Basic guest house / dormitories) with multi sharing and common washrooms.

**2: Below are planned places to stay in Overland route**

- Kathmandu: Hotel on twin / triple sharing basis, attached toilet. Saga & Darchen: Hotel on triple sharing basis, attached toilets. Kodari, Nylam, Mansarovar, Derapuk & Zutulpuk : Basic guest house / dormitories on (made of board / tin sheets ) multiple sharing basis. Basic common toilets at Kodari & Nylam, open toilets at Mansarovar, Derapuk & Zutulpuk.

**3:** I understand that shared itinerary & plan are tentative & can be changed / modified if required in case of weather issues, too much rush at any place of in Yatra or any other thing beyond Trip To Temples control.

I understand that water supply in Tibet side hotel is twice a day only (morning & evening)

**4:** I understand that this Yatra is not luxury. I am joining Trip To Temples group for just Yatra purpose & assure not to pressurize extra favor / services / priority over other group members by alluring money or putting unnecessary pressure.

**5:** I understand that any kind of insurance is not part of package & its my responsibility to be adequately insured. I understand that any kind of medical, evacuation, hospitalization, ambulance or extra transportation is not part of package & I am liable to pay any such kind of charges.

**6:** I assure you that I will not keep fasting during Yatra & will timely take if some medication if going on.

**7:** I understand that Ashtapad visit cost is not included in package. If Ashtapad is allowed by authorities there & I wish to go, I will pay the amount directly there (approx. 500 Yuan / person).

**8:** I have read T&Cs in detail & understand that Itinerary might be changed / modifies by authorities during the Yatra also depending on availability of accommodation, sudden rush, health of pilgrims or any other reasons need to be addressed there during the Yatra.


